Figure A1. Share of variance explained by job and occupation (dashed line), wages not logged. Source: EU-SILC 2005-2014.

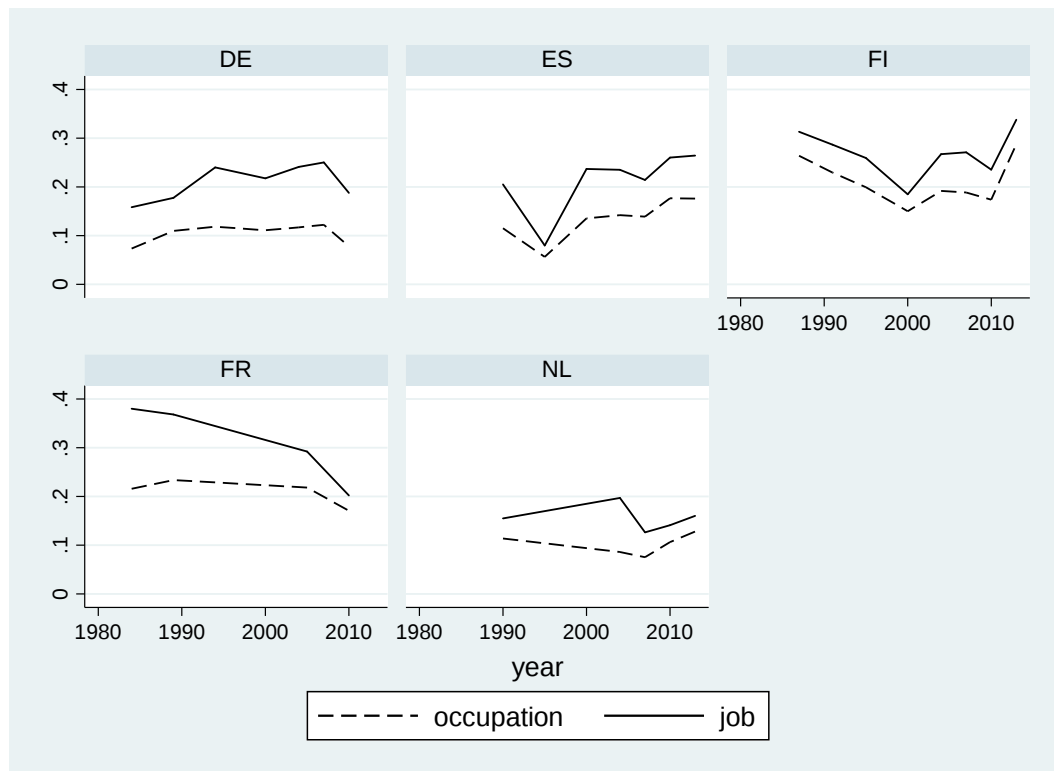


Figure A2: Share of variance explained by job and occupation (dashed line), wages not logged. Source: LIS database.
