**Are smart sanctions smart enough?**

**An inquiry into when leaders oppress civilians under UN targeted sanctions**

This document provides the list of 56 smart sanction episodes between 1991 and 2016 and the results of robustness checks that could not be included in the text due to space constraints. Models 6-9 in Table A2 test whether our results are sensitive to the exclusion of some episodes and to a change in the operationalization of political institution. Here we exclude episodes where one of the purposes was to ‘signal’ a target’s violations of human rights. In addition, we increase the threshold level of Polyarchy index that is used to code the *autocracy* variable. It is now coded as 1 if the Polyarchy index is less than or equal to 0.25, and is coded 0 otherwise. In Models 10-14 of Table A3, we further test the robustness of our findings using an alternative measure of political terror scale – namely, the PTS-Amnesty – as a dependent variable, while otherwise keeping Models 6-9 unchanged.

These changes make no substantive difference for our main findings. The only exception is that there is no longer a significant interaction between *duration* and *coercion* in Model 6. Perhaps, this is because relatively small number of sanctions are effective in coercing a target’s behavior. Within our sample, sanctions with coercive purposes were effective only 17% of the time. In Model 11, on the other hand, the interaction between *duration* and *coercion* remains marginally significant ( $p < .056$ ) in the expected direction. Also noteworthy in Model 10 is that *duration* has significant negative signs, suggesting that, on average, human rights conditions of target countries tend to improve over time during smart sanctions.
